# Student Mobility

## Requirements for application

- ▶ To be a second-year student in the academic year of mobility
- ▶ To provide minimum GPA requirement on the date of application  
for undergraduate students **2.20/4.00**  
for graduate students **2.50/4.00**
- ▶ To have a certain level of foreign language knowledge  
European Language Portfolio (ELP) at least B1 or B2 level
- ▶ Online application and delivery of documents

*\* For each applicant, a Foreign Language Level must be determined. Without submitting the Erasmus Foreign Language Assessment Exam, candidates may submit their scores from the examinations conducted by ÖSYM or YÖK in the last two years.*

*\* There is minimum score application for Foreign Language Level. (60 points out of 100)*

*\* Foreign students registered in a degree program may also apply.*

*\* Students who have previously benefited from any mobility activity (learning or internship) under the LLP or Erasmus + Program may also apply.*

*\* However, a student cannot perform an activity (education or internship) in the same level of education (undergraduate, graduate or doctoral) for more than 12 months, with or without scholarship.*

## How evaluation is carried out?

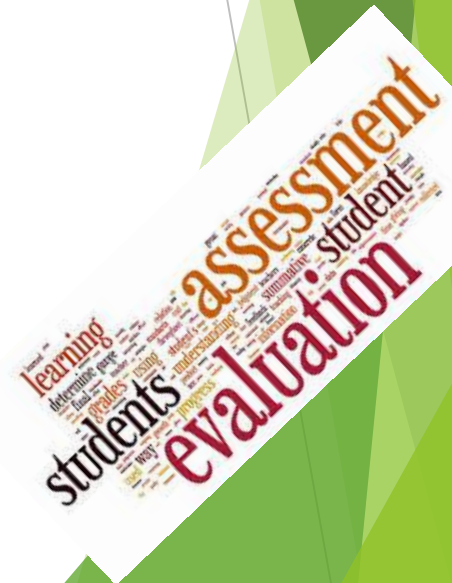
Criteria determined by the National Agency

critierion	points
GPA	%50 (over 100 points)
Foreign language level	%50 (over 100 points)
The children of martyrs and veterans	+15 points
For disabled students	+10 points
Use before (with or without grant)	-10 points
Participation in mobility in the country of citizenship	-10 points
To renounce the activity of erasmus before	-10 points

According to Erasmus score  
(within the faculty / department and within the specified quota)  
Ranking and Placement (one or two semesters)

# Student Mobility

For the duration of study abroad, the grant payment will be given to the participating students.



Travel, visa, insurance costs are not supported separately.

Grant payments  
80% prior to mobility  
and 20% after completion  
in two installments.

Grants are paid in bulk but not monthly.

# Student Mobility

## Erasmus Process Calendar



Call for applications **At the beginning of March**

The exam of the foreign language **Early April**

Announcement of results **In the first half of April**

Information / Orientation Meeting **Second week of April**

Waiver time (**~ 10 days**)

Determination of substitute candidates (**as soon as possible**)

Fall semester candidacy notices (Deadlines determined by the universities to be hosted)

**April-May-June**

Fall semester application process (Following nomination notices)

**April-May-June-July**

Spring term nomination notices (Deadlines determined by the universities to be hosted)

**October-November-December**

Spring semester application process (Following nomination notices)

**October-November-December**

Visa process

Contract signing and grant payments (**before mobility begins**)

*There may be a delay in grant payments for the fall semester! Prepay!*

(According to the academic calendar of the visiting schools)

Mobility onset: Fall semester / Full year: **August / September/October** Spring semester: **January / February / March**

End of Mobility: Fall Semester: **January / February** Spring Semester / Full Year: **May / June / July**

# Student Internship Mobility

- ▶ Internship activity → the student obtains practical work experience in the field.
- ▶ It can be done in a university, institute, business, organization in Europe.
- ▶ Internship activity cannot be an academic activity in order to complement or support students' own scientific studies.
- ▶ Bachelor's, master's and doctoral students registered in a degree program can apply and benefit from.



# Student Internship Mobility

- ▶ Internship mobility should be at least 2 months.
- ▶ Successful internship activity can be considered as a compulsory internship. Students who do not have compulsory internship may also benefit.
- ▶ New graduates can also benefit from the program, provided that they have applied before the graduation and have been selected as a participant candidate.
- ▶ Students cannot be selected to participate in Internship Mobility without an predetermined university, institute, business, organization

# Student Internship Mobility

- ▶ The prerequisite for the evaluation of the application is that the student submits a letter of intention / invitation to the internship activity that s /he plans to make from an enterprise / institution / higher education institution that he / she finds through his own initiatives and connections.
- ▶ The applicant must meet the minimum GPA requirements on the date of application.  
for undergraduate students **2.20 / 4.00** for graduate students **2.50 / 4.00**
- ▶ The applicant must have a certain level of foreign language knowledge in order to be selected.

European Language Portfolio (ELP) at least B1 or B2 level

The evaluation criteria used when evaluating applications are the same as the Learning Mobility.

- \* For each applicant, a Foreign Language Level must be determined.  
Without entering the Erasmus Foreign Language Assessment Exam, candidates may submit the scores they have taken in the last two years by the **ÖSYM or YÖK**.
- \* There is a minimum score for Foreign Language Level. (55-60 points out of 100)
- \* Foreign students registered in a degree program may also apply.
- \* Students who have previously benefited from any mobility activity (learning or internship) under the LLP or Erasmus + Program may also apply.
- \* However, a student cannot perform an activity (education or internship) in the same level of education (undergraduate, graduate or doctoral) **for more than 12 months**, with or without scholarship.

# Student Internship Mobility



- ▶ Monthly support grant 100 € more of grants in learning mobility for each country category.
- ▶ The call for Internship Mobility is issued in December, and a deadline of approximately two months. At the beginning of March, a foreign language exam is conducted and the results are announced.
- ▶ Internship mobility usually begins after the end of the academic year. Completed in the summer period.
- ▶ The internship activity must be completed by 30 September at the latest.

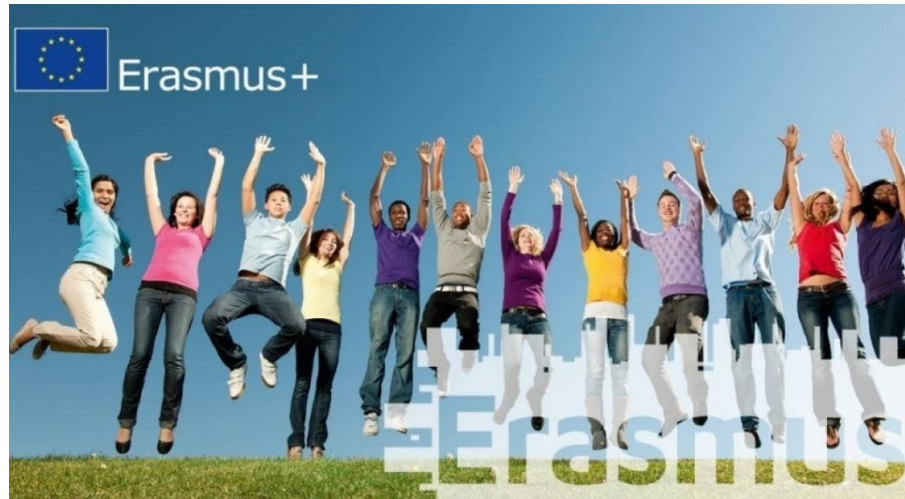

# Erasmus + Program



Erasmus + is not a language learning program.

Erasmus + is not a full scholarship program.

Although the beneficiaries are mainly undergraduate and graduate students, the program is open to all educational levels.

The use and responsibility of the grants belong to the student; Visa, travel, accommodation, charges are not paid.

The program can also be used as a non-granting or partial grant student.

Students are required to take courses of 30 ECTS (ECTS) credits for a semester and to be successful in 2/3 of their total load.

In the event of serious academic failure and failure to fulfill its obligations, a refund of the paid grant is requested.
